

AUTHOR GUIDELINES

for Scientific Collection
“Anthropological Measurements of Philosophical Research”

General terms

The scientific collection is a peer-reviewed professional publication, which presents scientific articles that cover and comprehend the new facets of human existence at the beginning of the new millennium.

The collection accepts for publication the problematic, generalizing and reviewing articles in Ukrainian, Russian or English languages, which had not been published before.

Sections of the collection

- Anthropological Modernist Project
- Anthropological Postmodern Quest
- Philosophy of Culture
- Philosophical Problems of Technology and Human Being
- Social Philosophy and Philosophy of History

Articles sent to the editorial board should have:

1. License agreement between the author (s) of the article and the editorial board of the collection ([link](#)).
2. File with information about each of the authors - full name, surname and patronymic; position, place of work; scientific degree; contact information (telephone, e-mail address); ORCID code. Information about the authors is submitted in three languages - Ukrainian, Russian and English.
3. File of the article on 8-10 pages. (Font 12) - up to 45,000 characters with spaces.
4. Recommendation for the publication of one doctor of philosophical sciences, who is not the scientific leader of any of the authors (co-authors) of the article.

Structure of the article

1. **UDC identifier** (in the upper left corner of the page) – in the first line with left alignment (TNR 12, boldface), interval before – 0 pt, after – 12 pt.
2. **Information about authors:** surname, first name and patronymic (initials), place of work, country, e-mail and ORCID. Interval before – 0 pt, interval after – 12 pt.
3. **Title of an article** – left aligned (Type – TNR 14, bold, capital letters. Interval after – 12 pt.).
4. **Abstract** (one paragraph, 250 – 300 words) – full justified, structured (according to the logic of results description in the article), it should contain the following elements with their explicit selection: **purpose, theoretical basis, originality, conclusions**. The abstract should not repeat the text of the article and its title, should not contain numbers, formulas, tables, inline footnotes, references and abbreviations. Type TNR 10. Interval after – 0 pt. The abstract is made in Ukrainian, Russian and English.
5. **Keywords** (6-12 separate words and/or as a part of word combinations) – full justified (TNR 10, interval after – 12 pt).
6. **The text** of the article should be structured and have elements: **introduction, purpose, presentation of the main material, originality, conclusions**. The text of the article is placed in two columns of equal width with the space between columns 0.5 cm.
7. **References to literature sources** (bibliographic description of the sources used in preparing the article, in original language) formatted according to the standard "DSTU 7.1: 2006. Standard system of information, librarianship and publishing. Bibliographic record. The bibliographic description. General requirements and rules", which is valid from 01.07.2007;

8. **References** – transliterated References (in Latin); APA-style.
9. **Information about the reviewer** who recommends the article for publishing (with no less than Professor or Doctor degree in the corresponding field). *Anonymous review is provided by the editorial board.*

More about the elements of the article:

- **Introduction:** *rationale* of the research, *problem statement* in general and its relevance to important scientific or practical tasks. *Justification of the novelty* of the research due to the degree of problem evaluation on the basis of *analysis of the references* with the *obligatory consideration of recent publications* in foreign philosophic literature (3-4 years ago) with quotations and references in which the solution to the problem was initiated or continued with the allocation of previously unsettled parts;
- **Purpose** with the study task definition;
- **Presentation of the main material:** the theoretical basis and the complete substantiation of the new scientific results obtained;
- **Originality** includes theoretical data, new approaches to material comprehension and a new solution to the problem, which is a significant step forward in comparison with previous studies;
- **Conclusions:** briefly outlined findings of the study and prospects for further research.

Requirements for the list of references

- The volume – 10-20 sources (excluding review articles);
- The major part of references should reflect the current state of scientific research and be not older than 3-4 years;
- There can be no more than 20% of self-references to each of the co-authors;
- No less than 3 links in Latin (to foreign journal with a high impact factor no older than 3 years or base monograph). *All sources must have the DOI.*

According to the recommendations of international citation databases the reference list should contain the core sources that have influence on the development of the science (core is a small part of the overall list).

List of references should be formatted according to the standard "DSTU 7.1:2006. Standard system of information, librarianship and publishing. Bibliographic record. The bibliographic description. General requirements and rules", which is valid from 01.07.2007 (examples and style of typing – see Appendix 1).

Attention! In accordance with the requirements of SCOPUS and Web of Science for REFERENCES one should submit a *complete list of co-authors* for each reference source (as opposed to the requirements specified in DSTU).

Primary sources are given in original language.

List of references is sorted **in alphabetical order and breadthwise**. It is titled СПИСОК ИСПОЛЬЗОВАННЫХ ИСТОЧНИКОВ (in Russian article), СПИСОК ВИКОРИСТАНИХ ДЖЕРЕЛ (in Ukrainian articles) and LIST OF REFERENCES (if the article is in English). – TNR 11 pt., in capital letters. This list is separated from the main text and from the list of references by the intervals before 12 pt. and after 6 pt. and is placed in the middle of the column.

Bibliographic description of each source should be accompanied, in case of presence, with its Digital Object Identifier (DOI), which is given space-separated after the source bibliographic description. DOI of publications can be found at: <https://www.crossref.org/>

Requirements for transliterated references

Transliterated reference, as required by scientometrical databases of SCOPUS and Web of Science, is a complete reference analogue and is performed by Latin transliteration of the original language. Herewith the procedure and the number of sources in the reference list should remain unchanged. Links to English sources are not transliterated.

Attention! The References should be formatted according to **APA style** (American

Psychological Association). You can format citations according to the APA style on the site of the online automatic link formation: Citation Machine (<http://www.citationmachine.net/apa/cite-a-book>); <http://www.bibme.org/apa/book-citation/manual> or another site.

The decree of the Cabinet of Ministers of Ukraine from 27 January 2010 № 55 "On regulation of transliteration of the Ukrainian script into Roman script" approves the official transliteration of the Ukrainian script into Roman script, establishes the current rules of transliteration of the names and surnames of Ukrainian citizens into Roman script in the foreign passports. Online transliteration – <http://translit.kh.ua/?passport>.

For the Russian language: transliterate in accordance with the requirements of the order of the Federal Migration Service of Russia as of February 3, 2010, No. 26. Online transliteration: - Translations in Russian (<http://ru.translit.net/?account=zagranpassport>).

If the domestic journal has a parallel English version, use the translated article name and the corresponding journal name.

If the domestic journal is translated into English, use the English version of the journal name and the article. Specify the range of pages of the translated journal version.

For control! Cyrillic script in Latin checking program (and vice versa - Latin in Cyrillic): - Cyrillic letters in the Latin text (<http://aruseni.alwaysdata.net/layouthighlight/>).

Payment for publication

Taking into account the transition of the scientific collection from 2017 to full self-sufficiency, the cost of publication will be as follows:

- Manuscript up to 10 pages - 800 UAH (font 12);
- Each additional page - 60 UAH.

The payment for publishing an article is made after reviewing (by an independent expert), a positive feedback from the editorial board and the editorial board's consent to publication (with the provision of payment details). The publication fee covers the full cycle of manuscript processing and layout of the articles. The publication fee does NOT include the cost of a printed copy and its shipment to the authors.

Final provisions

- It is not acceptable to submit materials in violation of the rules established by the publishing house, in violation of any requirements to the editions;
- Do not submit texts obtained with the help of automatic translation programs;
- Do not submit the materials unprepared and incomplete by authors;
- Do not delay the materials provided by the publishing house for correction.
